In addition, performing oversight and tracking of change requests, change notices and facilitating change control board (CCB) activities to achieve versioning control. This role also provides review and feedback of change requests for all items under versioning control to ensure compliance to configuration management processes and to achieve configuration management goals.

- Provide version control and maintain records (whether physical or electronic) for a variety of business items as required by procedures, processes and work instructions to include:
  - <u>Products:</u> BOM's, assemblies, assembly documents, source control documents, design documents, design source, design environment settings, design process artifacts, design requirements, manuals, specification sheets, test plans, test reports, test procedures, Configuration Status Lists (CSL's), Operations work instructions, etc.
  - o ISO 9001 / AS9100: Processes, Procedures, Work Instructions, standard templates, etc.

- <u>Contracts</u>: Non-Disclosure agreements, Contracts & contract deliverable documents, customer change approval records, etc.
- Track efficiency of the change process and report metrics associated with the change process.
- Provide support to project teams in configuring and base-lining project items.
- Ensure document distribution to all functional groups within the Company.
- Review of engineering changes to determine impact on hardware / software and configuration records for consistency of versioning and proper disposition of affected items in manufacturing.
- Using configuration records, generate and maintain Configuration Status Lists (CSL's).
- Coordinate the preparation and / or delivery of engineering / configuration data to customers or suppliers when required.
- Control and maintain ERP database information as it relates to item setup and BOM's.
- Perform other duties as assigned.
